Savinvest India/Asia Fund saw 1,000 shares crossing the floor with its price falling 2.10 per cent from \$71.50 to \$70.00. There were no trades in Fortress Caribbean Property Fund or Praetorian Property Mutual.

Weekly Summary

Activity on the floor of the Stock Exchange picked up considerably this week as a total of 1,165,371 shares changed ownership. This was 104.67 per cent more than last week's volume of 569,396. The value of shares traded was \$12,547,033.49. Bearish market conditions continued to be prevalent as both Indices experienced declines from last week's close. The Composite Index fell 0.60 per cent to 920.3354 while the All T&T Index declined 0.19 per cent to 1,168.3817. Advances were outnumbered by declines by a 4 to 14 margin.

Volumes were driven by Sagicor Financial Corporation which saw a total of 331,610 shares crossing the floor. This was 28.46 per cent of the market. Jamaica Money Market Brokers followed with 272,847 shares traded or 23.41 per cent of all trades. National Flour Mills was next with 128,361 shares changing hands or 11.01 per cent of all trades.

The major advance of the week belonged to National Flour Mills which rose 1 cent or 0.67 per cent to \$1.50. First Caribbean International Bank (FCIB) followed increasing 2 cents or 0.18 per cent to \$11.35. This week CIBC finalised the deal with Barclays to acquire Barclays' 43.7 per cent ownership stake in FCIB. The deal was finalised at a price of Bds\$3.24. After falling \$2.00 last week, AnsaMcal Limited was up 3 cents or 0.08 per cent to \$40.03.

The three major declines of the week were all from regionally based Companies. Capital & Credit Merchant Bank fell 10 cents or 6.49 per cent to \$1.44. Week on week this share fell 3.33 per cent in Jamaica from Jca\$15.00 to Jca\$14.50. Another Jamaica company, GraceKennedy & Company followed falling 39 cents or 6.10 per cent to \$6.00. Though there was no change in price from last week's close of Jca\$60.50 in Jamaica, the share fluctuated during the week on that market. Barbados Shipping and Trading fell \$1.00 or 5.26 per cent to \$18.00.

In Jamaica, all three Indices were down from last week's close. The Market Index dropped 1.53% to 85,108.21, the Select Index fell 1.52% to 2,182.25 and the All Jamaican Composite declined 0.32% to 79,663.62.
