EQUITY SUMMARY

Trinidad and Tobago

Volumes traded on the First Tier Market this week were up on last week's volume by 294.47 per cent with a total of 2,078,314 shares changing hands compared to 526,860 shares traded in the previous week. The value of shares traded was \$10,319,357.43, up 39.24 per cent when compared to last week's value of \$7,411,392.24. The volume leader was National Commercial Bank Jamaica Limited (NCBJ) with 759,987 shares traded or 36.57 per cent of all trades.

With regards to Indices movement, both the Composite and the Cross Listed Indices registered advances this week while the All Trinidad and Tobago Index closed lower. The Composite Index added 1.11 points or 0.11 per cent to 991.03, the All Trinidad and Tobago Index slipped 1.57 points or 0.11 per cent to 1,450.19 and the Cross Listed Index rose 0.42 points or 0.63 per cent to 66.88.

The top gainer this week was Jamaica Money Market Brokers Limited (JMMB) which registered a gain of 6.58 per cent or \$0.05 to close at \$0.81 while the major decline was Trinidad Cement Limited (TCL), down 9.09 per cent or \$0.20 to \$2.00. Advances were outnumbered by declines by a close ratio of 9 to 10.

There was no activity on the Second Tier Market or Mutual Fund Market this week.



Jamaica

In Jamaica, the three major Indices closed the week on a positive note. The JSE Market Index improved 2,823.90 points or 2.89 per cent to 97,874.04, the JSE Select Index gained 153.08 points or 5.05 per cent to 3,030.00 and the JSE All Jamaican Composite soared 4,693.32 points or 4.41 per cent to 106,324.66. Market activity resulted in 34,270,074 shares traded valued at over J\$251,773,229.52. The volume leader this week was Cable and Wireless Jamaica Limited (CWJA) with 34.08 per cent of the market or 11,679,412 shares.

November 4 – Scotia investments Jamaica Limited – Management Changes

Scotia Investments Jamaica Limited informed the Exchange that effective October 25, 2011 and October 31, 2011, Mr. Daniel Robert Wright and Ms. Anya Schnoor respectively resigned as Directors of the Company.

It also noted that effective October 25, 2011, Ms. Catherine Welling was appointed to the Board of Directors of Scotia Investments.

October 31 – BCB Holdings Limited – Completion of Demerger Announcement

Belize City, Belize, 26 October 2011. BCB Holdings Limited (London – AIM: BCB; Trinidad and Tobago Stock Exchange – BCBTT; Bermuda – BBHL) (the “Company”) announced at the General Meeting of the Company held on October 26 that a resolution approving the reorganisation of the Company and its subsidiaries (the “Group”) by the demerger of the Group’s non-Belizean businesses to Waterloo Investment Holdings Limited (“WIHL”) was approved. The board of directors of the Company also approved all relevant steps and the demerger is now effective. Ordinary shares in WIHL will be traded on JP Jenkins from October 27, 2011 on a matched bargain basis.

In addition, the Company confirms that Andrew Ashcroft and Philip Johnson have now stepped down from the board of Directors and Cheryl Jones is now non-executive Chairman.

The Company also confirmed that the new exercise price for the warrants, which are admitted to trading on AIM, is US\$1.95 and that the options in the Company have also been amended to reflect an exercise price of US\$1.95. The options vest and become exercisable in three equal installments on August 1 2012, August 1 2013 and August 1 2014 and they lapse on August 1 2019.
