Mora Ven Holdings Limited (MOV) saw 2,000 shares cross the floor this week. The share closed the week at \$5.28, up 48 cents or 10.00 per cent on its last close.

Local Market Summary

The four-day trading week saw a total of 2,902,780 shares change ownership, down 5.33 per cent on last week's volume of 3,066,273 shares. The value of shares traded was \$37,022,228.52, down a minimal 0.62 per cent when compared to the previous week's value of \$37,253,089.68.

Both Indices continued to trend upward this week with the Composite Index up 0.49 per cent or 5.5124 points to close at 1,141.0519 while the All T&T Index rose 0.86 per cent or 12.6189 points to 1,472.5735. The advance to decline ratio ended the week at 12 to 6.

The Non-Banking/Finance Sector was in the spotlight this week as 70.41 per cent of the market activity came from this sector. Sagicor Financial Corporation (SFC) captured the title of volume leader with 680,914 shares traded or 23.46 per cent of all trades. Jamaica Money Market Brokers (JMMB) followed with 486,550 shares traded or 16.76 per cent of the market. Next was National Enterprises Limited (NEL) which saw 391,592 shares change hands or 13.49 per cent of the total volume traded.

For a second consecutive week, the major advance this week went to Readymix (West Indies) Limited (RML) which rose \$1.43 or 10.00 per cent to close at \$15.73. The second major advance was ANSA Merchant Bank Limited (AMBL), up \$1.96 or 6.99 per cent to end the week at \$30.01. Angostura Holdings Limited (AHL) was next, rising 28 cents or 5.74 per cent to \$5.16.

Jamaica Money Market Brokers Limited (JMMB) was the major decline for the third week in row. This share fell 6 cents or 4.76 per cent to \$1.20. GraceKennedy Limited (GKC) followed, down 15 cents or 1.78 per cent to close at \$8.30. The third major decline was National Flour Mills (NFM) which fell 1 cent or 0.87 per cent to end the week at \$1.14.
