#### **EQUITY SUMMARY**

This week saw 4,760,502 shares traded on the First Tier Market, an increase of 99.52 per cent on last week's total of 2,386,037 shares crossing the floor. The value of the shares traded was down 15.80 per cent to \$27,244,966.47 from the previous week's value of \$32,358,293.67. Grace Kennedy Limited (GKC) was the volume leader this week with 30.06 per cent of the market activity or 1,430,830 shares traded, followed by National Enterprises Limited (NEL) with 25.58 per cent of the market activity or 1,217,751 shares traded. In third place was JMMB Group Limited (JMMBGL) with 18.34 per cent or 872,961 shares traded. These shares accounted for 73.97 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index decreased by 0.13 per cent or 1.56 points to close at 1,193.99. The All Trinidad and Tobago Index ended at 1,785.20, a decline 0.09 per cent or 1.59 points. The Cross Listed Index slid by 0.28 per cent or 0.22 points to close at 78.57. The Small and Medium Enterprise Index ended at 77.95 unchanged from the previous week. This week there were 7 shares advancing and 12 shares declining, while 2 shares were at their 52-week high and 1 share were at their 52-week low.



The major advance this week was Prestige Holdings Limited (PHL) up 8.01 per cent or \$0.89 to close at \$12.00, its 52-week high. In second place was Agostini's Limited (AGL) with an increase of 2.22 per cent or \$1.50 to close at \$69.00, The West Indian Tobacco Company Limited (WCO) followed with an increase of 2.14 per cent or \$0.20 to close at \$9.55.

One Caribbean Media Limited (OCM) was the major decline this week down 7.69 per cent or \$0.29 to close at \$3.48, Point Lisas Industrial Port Development Corporation Limited (PLD) followed with a decrease of 7.02 per cent or \$0.28 to close at \$3.71. In third place was Massy Holdings Limited (MASSY) down 2.05 per cent or \$0.09 to close at \$4.30.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 320 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$7,300.00. CALYP's unit price closed at \$22.75 up 1.11 per cent or \$0.25.

On the Small and Medium Enterprise Market, no Endeavour Holdings Limited (EHL) and CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$14.80 and CINE1 closed at \$6.45, both unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


