## **Trinidad and Tobago**

This week saw 557,013 shares traded on the First Tier Market a decline 45.56 per cent on last week's volume of 1,023,256. The value of shares traded, decreased 46.16 per cent from \$8,655,490.73 in the previous week to \$4,659,805.87 this week. For the third consecutive week JMMB Group Limited (JMMBGL) was the volume leader capturing 28.51 per cent of the market with 158,790 shares traded.

The Indices ended the week mixed. The Composite Index rose 0.20 per cent or 2.52 points to close at 1,240.41, the All Trinidad and Tobago Index decreased 0.09 per cent or 1.64 points to end at 1,790.06 and the Cross Listed Index closed at 92.77, up 1.01 per cent or 0.93 points. This week there were 5 stocks advancing and 4 stocks declining. The major advance was JMMB Group Limited (JMMBGL), up 6.50 per cent or \$0.08 to close the week at \$1.31 and the major decline was Trinidad and Tobago National Gas Limited (NGL), down 4.35 per cent or \$1.00 to end at \$22.00.



There was no activity on the Second Tier Market this week. On the TTD Mutual Fund Market 33,303 CLICO Investment Fund (CIF) units traded with a value of \$690,700.97. CIF's price fell 0.24 per cent or \$0.05 to close at \$20.70.

# Sep 01 – National Enterprises Limited - Resignation of a Director

The Trinidad and Tobago Stock Exchange Limited (TTSE) received notice from NEL advising that Mr. Anthony Clerk has resigned as a Director of NEL effective August 31st, 2017.

#### Sep 01 – Scotia Investments Jamaica Limited - Scheme of Arrangement Approved by Shareholders

Shareholders of Scotia Investments Jamaica Limited (Scotia Investments) yesterday voted yes in favour of the Scheme of Arrangement whereby shares held by the minority shareholders are to be cancelled, and in consideration of which, shareholders shall receive J\$38.00 per share or the US\$ equivalent from the Scotia Group Jamaica Limited. The Extraordinary General Meeting commenced at 2:00 p.m. Jamaica time, 3:00 p.m. Trinidad & Tobago time, and was held at the Jamaica Pegasus Hotel, with a simultaneous video-link for shareholders based in Trinidad & Tobago at the Hyatt Regency Hotel, Port of Spain.

The preliminary results indicated that the shareholders of the company overwhelmingly approved the Scheme with 83 % of persons attending giving approval in person or by proxy, representing 99.95 % of the shares voted in favour.

Commenting on the shareholder vote, Jeffrey Hall, Scotia Investments Chairman said "We thank all our shareholders for the interest shown in the company and the Scheme of Arrangement that was proposed, and would like to assure all our clients that Scotia Investments remains committed to delivering the high quality advice and service to which you have become accustomed."

The Company will now seek to confirm a hearing date with the Supreme Court of Jamaica to sanction the results of the vote, and obtain the Court's final approval for the Scheme of Arrangement to take effect.

Once sanctioned by the Court, the Scheme becomes effective and the company will confirm with shareholders the distribution of monies based on the details of the Scheme of Arrangement.

Scotia Investments is a leading securities dealer in Jamaica. Its shares are listed on the Jamaica Stock Exchange and cross-listed on the Trinidad & Tobago Stock Exchange. It began operations in 1992 as Dehring Bunting & Golding Limited ("DB&G"). That same year it converted to a public company, made an initial public offer and was listed on the Jamaica Stock Exchange. In 2006, The Bank of Nova Scotia ("BNS Toronto") and its Jamaica subsidiary, The Bank of Nova Scotia Jamaica Limited ("BNSJ"), made a joint takeover bid to acquire a controlling interest in DB&G. The bid was successful and culminated in the bidders obtaining 77.1% of DB&G. Subsequent to the bid a Scheme of Arrangement was undertaken pursuant to which the shares acquired by BNS Toronto and BNSJ were vested in Scotia Group.
