## EQUITY SUMMARY

This week saw 664,913 shares traded on the First Tier Market, a decrease of 60.75 per cent on last week's total of 1,693,968 shares crossing the floor. The value of the shares traded was down 28.24 per cent to \$11,060,646.66 from the previous week's value of \$15,413,135.45. Massy Holdings Limited (MASSY) was the volume leader this week with 28.58 per cent of the market activity or 190,016 shares traded, followed by National Enterprises Limited (NEL) with 15.70 per cent of the market activity or 104,368 shares traded. In third place was Republic Financial Holdings Limited (RFHL) with 8.20 per cent or 54,520 shares traded. These shares accounted for 52.47 per cent of the shares traded this week.

The Indices ended the week in mixed territory. The Composite Index decreased by 0.06 per cent or 0.71 points to close at 1,218.03. The All Trinidad and Tobago Index ended at 1,835.73, an increase of 0.24 per cent or 4.42 points. The Cross Listed Index slid by 1.10 per cent or 0.87 points to close at 77.96. The Small and Medium Enterprise Index ended at 77.71 unchanged from the previous week. This week there were 5 shares advancing and 14 shares declining, while 3 shares were at their 52-week high and 2 shares were at their 52-week low.



The major advance this week was Prestige Holdings Limited (PHL) up 11.91 per cent or \$1.49 to close at \$14.00. In second place was Angostura Holdings Limited (AHL) with an increase of 10.87 per cent or \$2.23 to close at \$22.74, Unilever Caribbean Limited (UCL) followed with an increase of 6.18 per cent or \$0.74 to close at \$12.72.

Point Lisas Industrial Port Development Corporation Limited (PLD) was the major decline this week down 9.76 per cent or \$0.40 to close at \$3.70, Grace Kennedy Limited (GKC) followed with a decrease of 4.17 per cent or \$0.17 to close at \$3.91. In third place was The West Indian Tobacco Company Limited (WCO) down 1.94 per cent or \$0.30 to close at \$15.19.

There was no activity on the Second Tier Market.

On the TTD Mutual Fund Market, 581 Calypso Macro Index Fund (CALYP) units traded this week at a value of \$13,160.20. CALYP's unit price closed at \$22.60 a decline of 0.44 per cent or \$0.10 from last week.

On the Small and Medium Enterprise Market, 65 Endeavour Holdings Limited (EHL) shares traded valued at \$975.00, while no CinemaOne Limited (CINE1) shares traded this week. EHL's share price closed at \$14.75 and CINE1 closed at \$6.45 both unchanged from last week.

On the USD Equity Market, no MPC Caribbean Clean Energy Limited (MPCCEL) shares traded this week. MPCCEL shares closed the week at US\$0.98, unchanged from last week.


